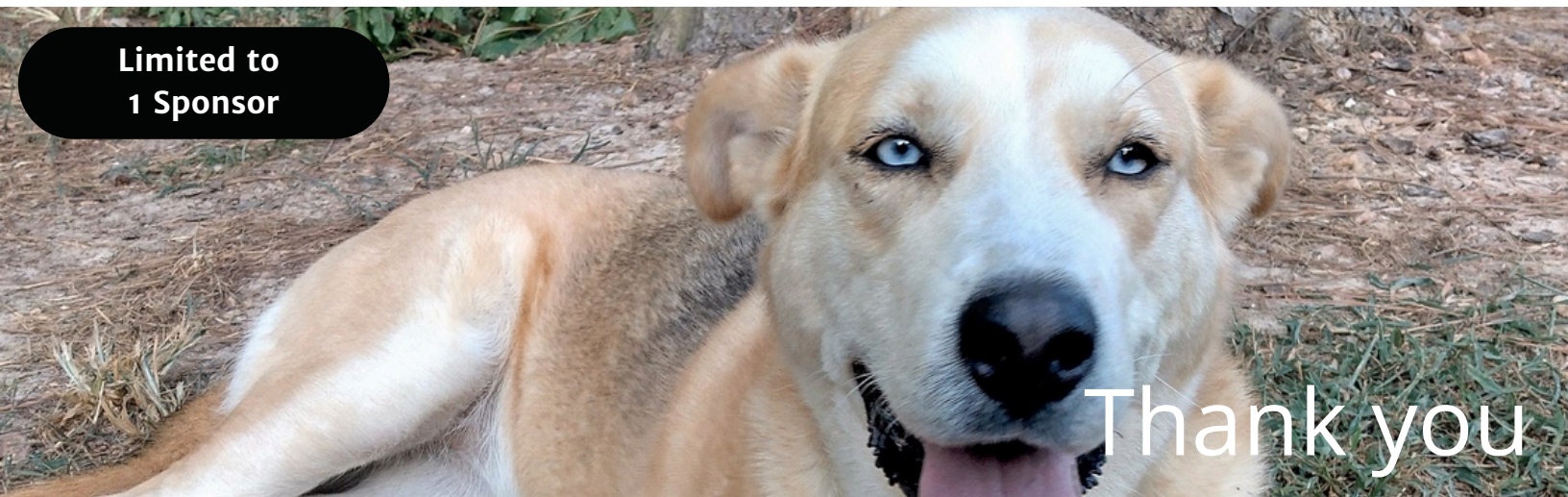

Auction Rules

PLEASE READ THE RULES BELOW IN THEIR ENTIRETY BEFORE BIDDING:

- You must register/create account and be logged in to make a bid.
- Read the full item description found on the bottom of the item Detail page where you can enter bid amount, as some items are NOT available for shipping, and some are sent to winners electronically. Shipping cost will be noted in the description, if item can be shipped. All local pickups will be at the Hollywood Feed in Cary on Saturday, Sept 13th 2-4pm and Sunday, Sept 14th 2pm-4pm.
- On the item Detail page simply enter your bid amount (in whole dollar increments, no decimals needed). The starting or current bid is highlighted in yellow, and all subsequent bids are required to be higher by the system.
- The highest bid submitted BEFORE the auction site time of 7pm EDT on Sunday, September 7th wins. Please note that your computer or phone clock may not be EXACTLY the same as the auction time. There is a countdown clock on each item Detail page.

Email Features

You will receive emails for the below actions but please be sure to set your email preferences/rules to ALLOW emails coming from sender: fundraising@bfpa.org or display name of BFPA Auction, otherwise they may go to SPAM folder.

- Placing a bid
- Being outbid
- A bid being placed on an item in your watchlist
- Winning an auction item
- Reminder to pay

Payment and Shipping

The ONLY method of payment is ONLINE. You can pay via PayPal WITH or WITHOUT creating a PayPal account. All payments must be made by Wednesday, September 17th by 12pm EDT or your bid will be deleted and the previous highest bid will win.

Shipping cost is calculated as part of your payment, per individual item. If you are requesting multiple items to be shipped, PLEASE ensure all items can be shipped - this is noted in the short description in the CART and on the All Auction items page. We will have a multi-item shipping amount, you can choose that if it is less than individual items together.

Event Sponsorship Agreement

Page 1 of 4

This Sponsorship Agreement (the "Agreement") is made and entered into as of the last signature date below (the "Effective Date") by and between BEST FRIEND PET ADOPTION INC. with an office at PO BOX 5305, Cary, NC 27512 ("BEST FRIEND PET ADOPTION") and the sponsor identified below ("Sponsor").

Event

BEST FRIEND PET ADOPTION is hosting the following event: 5th ANNUAL AUCTION (online via Facebook) starting on August 31st, 2025 and Sponsor desires to sponsor the Event.

In consideration of the mutual promises and covenants contained in this Agreement, the parties hereby agree as follows:

1. BEST FRIEND PET ADOPTION Obligations. In consideration for Sponsor's participation in the Event, BEST FRIEND PET ADOPTION shall provide the Sponsor the benefits set out in Appendix, which is incorporated and hereby made a part of this Agreement.

2. Sponsor Obligations. For its participation as a Sponsor in the Event, Sponsor shall pay to BEST FRIEND PET ADOPTION a fee (the "Sponsorship Fee"), as set out below:

GOLD SPONSORSHIP - \$500 or

SILVER SPONSORSHIP - \$300 or

BRONZE SPONSORSHIP - \$150 or

The Sponsorship Fee is payable to BEST FRIEND PET ADOPTION Inc., due on date of Agreement signing.

3. Sponsor Trademarks/Sponsor Materials. Subject to the terms and conditions of this Agreement, Sponsor grants to BEST FRIEND PET ADOPTION the right to use Sponsor's trademarks, trade names, and logo designs and company descriptions as prepared and delivered to BEST FRIEND PET ADOPTION by Sponsor ("Sponsor Materials"), in any medium of advertising, marketing materials, and/or promotional goods distributed solely in conjunction with the Event and in accordance with Sponsor's trademark usage guidelines.

4. Indemnity

4.1 BEST FRIEND PET ADOPTION shall not be responsible for any loss of or damage to property of Sponsor, its employees, agents, contractors or assigns nor for any personal injury to Sponsor's officers, directors, employees, agents, contractors and/or invitees except to the extent any such claims may be directly and solely attributable to the gross negligence or willful misconduct of BEST FRIEND PET ADOPTION, its directors, officers, and/or employees.

4.2 Sponsor shall indemnify, defend, and hold BEST FRIEND PET ADOPTION harmless from and against any claims arising out of, or relating directly or indirectly to, content on their respective web sites, use of Sponsor's trademarks and logos, and Sponsor Materials.

4.3 Sponsor will give BEST FRIEND PET ADOPTION prompt written notice of any claim or suit coming within the purview of these indemnities.

5. Limitation of Liability. Except with respect to Section 8.3, in no event shall either party be liable to the other party for any incidental, consequential, indirect, or punitive damages (including but not limited to lost profits) regardless of whether such liability is based on breach of contract, tort, strict liability, breach of warranties, failure of essential purpose or otherwise and even if advised of the possibility of such damages. Notwithstanding anything else in this Agreement, BEST FRIEND PET ADOPTION's liability for any claim against BEST FRIEND PET ADOPTION shall be limited to the funds available in its own bank account at the time of the claim.

6. Representations. Each party hereby represents and warrants that it has the full power to enter into and perform according to the terms of this Agreement.

7. Term and Termination

7.1 Term. Subject to the terms and conditions herein, this Agreement shall be effective upon the Effective Date and shall continue through September 14th, 2025, one week after the event closes, unless earlier terminated as otherwise provided in this Agreement (the "Term").

7.2 Termination by BEST FRIEND PET ADOPTION. BEST FRIEND PET ADOPTION shall be entitled to cancel the Event and/or terminate this Agreement at any time for any reason. In the event BEST FRIEND PET ADOPTION terminates this Agreement for any reason other than Sponsor's breach BEST FRIEND PET ADOPTION shall refund any fees received from Sponsor, and at Sponsor's expense, return any materials, and equipment, hardware and/or software loaned by Sponsor for the Event.

7.3 Termination by Sponsor; Effect of Termination

a) Sponsor may terminate this Agreement for breach by BEST FRIEND PET ADOPTION after giving BEST FRIEND PET ADOPTION at least ten (10) days prior written notice specifying the nature of the breach and giving BEST FRIEND PET ADOPTION no less than ten (10) days to cure such breach. In the event such breach remains uncured at the end of the notice period, this Agreement shall terminate on the tenth day. If breach occurs fewer than ten (10) days prior to the Event, Sponsor may terminate this Agreement for breach if such breach is not cured by the first day of the Event.

b) If BEST FRIEND PET ADOPTION terminate this Agreement for Sponsor's breach, BEST FRIEND PET ADOPTION shall retain any fees received from Sponsor which fees shall be due and payable notwithstanding any such termination. Any equipment, materials and hardware or software of Sponsor shall be returned at the end of the Event and, in the interim, may be used for the purposes contemplated herein notwithstanding such termination.

c) If Sponsor terminates for BEST FRIEND PET ADOPTION's breach, Sponsor shall be entitled to seek a full refund of any fees paid and for the return of any equipment, materials and hardware or software of Sponsor.

7.4 Survival. In the event of termination or expiration of this Agreement, paragraphs 4, 5, 6, 7 and 8 shall survive.

8. Miscellaneous

8.1 Notices. All notices, authorizations and requests in connection with this Agreement shall be deemed given on the day they are (i) deposited in the mail, postage prepaid, certified or registered, return receipt requested; (ii) sent by air express courier, charges prepaid; or (iii) sent by fax as indicated by a fax confirmation sheet; and sent to the address in the recitals. Sponsor agrees to send a copy of any notices, via email to: bfpafundraisingteam@gmail.com.

8.2 Relationship. This Agreement does not constitute and shall not be construed as constituting a partnership, or joint venture relationship between or among the parties.

8.3 Confidentiality. Each party expressly undertakes to retain in confidence all information and know-how transmitted to it by the other party that the disclosing party has designated as proprietary and/or confidential or that, by the nature of the circumstances surrounding the disclosure, ought in good faith to be treated as proprietary and/or confidential, and will make no use of such information and know-how except under the terms, for the purposes of and during the existence of this Agreement. Each party's obligation under this Agreement with respect to any particular information shall extend to the earlier of such time as such information is publicly available through no fault of the receiving party or five (5) years following termination of the Agreement.

8.3 Governing Law/Jurisdiction. This Agreement shall be governed and interpreted in accordance with the laws of North Carolina. Sponsor consents to the exclusive jurisdiction and venue of the courts in North Carolina.

8.4 Assignment. This Agreement may not be assigned by either party without prior written consent of the other party.
